

1. Acceptance of Terms and Conditions

- HALAL INDIA PVT LTD ("HI"), a company incorporated in India (Company Incorporation Number: U74910PY2009PTC002337) manages the internet portal www.halalindia.co.in ("HI Website") and the Services ("Services" as hereinafter defined below) offered on the HI Website, subject to the following Terms and Conditions ("Terms").
- 2. The Terms apply to your access and use of the HI Website and/or the Services. By accessing any page of the HI Website and/or using the Services, you agree to be bound by the Terms without limitation or qualification.
